The renter agrees to indemnify the ICS and hold harmless its agents, employees, Shura members, and board of directors from and against any and all losses, costs, claims, or demands in respect to any injuries, including death, losses or damages to any property belonging to the renter that may occur during the duration of this rental.
- 8. No wall and/or ceiling decorations shall be allowed. Additionally, no outside tents are allowed.
- 9. The ICS is a non-smoking facility. No smoking is in effect at all time in and around ICS property.

- 10. Renter agrees to vacate the ICS premises by 11PM, after which an additional fee of \$50/hr will be charged.
- 11. If the renter wishes to use ICS linens for tables, there will be an additional charge of \$7/sheet that needs to be paid at the time of booking.
